Mobile AMD Athlon™ XP-M Processor

The following information addresses the correct treatment of the Mobile AMD Athlon™ XP-M processor logo and trademarks for use in advertising, technical communications, marketing collateral, and other printed, Web, or visual materials.



General Guidelines

An AMD processor logo may only be used in connection with the promotion of the corresponding AMD processor and not for other goods and/or services. Do not modify or re-create an AMD processor logo under any circumstances. Use the artwork provided by Advanced Micro Devices, Inc.

The following trademark attribution must be used when featuring the Mobile AMD Athlon XP-M processor logo:

AMD, the AMD Arrow logo, AMD Athlon, and combinations thereof, are trademarks of Advanced Micro Devices, Inc.

Follow the more detailed rules set forth in the Trademark Usage Guidelines for Mobile AMD Athlon XP-M regarding all text references.

The Mobile AMD Athlon™ XP-M Processor Logo

The Mobile AMD Athlon™ XP-M processor logo, consisting of the AMD corporate logo and the Mobile AMD Athlon XP-M logotype bound by a unifying elliptical element, is illustrated to the right. Shown below it are the correct color treatments in positive and reverse. Whenever possible, the Mobile AMD Athlon XP-M processor logo should be presented in its full-color version.

Sufficient Contrast Requirements

There are four Mobile AMD Athlon XP-M processor logo versions for use in various types of executions (i.e., placement over white, black, light/dark colors, or photos). Examples of these executions are illustrated to the right. Consider the following points when choosing the most appropriate logo version:

- Always use the logo version most appropriate for the particular execution to achieve optimal contrast between the logo and its background.
- Reverse and black versions of the Mobile AMD Athlon XP-M processor logo are available for use over a photo.
- Never place a full-color version of the logo over a photo.

Color Requirements

The color diagram to the right identifies the color of each element of the mobile AMD Athlon™ XP-M processor logo. We have provided a color list below that will assist in the correct reproduction of the mobile AMD Athlon XP-M processor logo in the most commonly used media formats.

CMYK

(4-color process printing such as: advertisements, marketing collateral, magazines, etc.)

AMD Green = C: 100 M: 0 Y: 79 K: 0

Orange = C: 0 M: 43 Y: 87 K: 0

Black = K: 100

Spot Color

(Multi-ink printing such as: business cards, letterhead, etc.)

AMD Green = Pantone 347

Orange = Pantone 151

Black = Black

RGB

(Electronic representations such as: CD demos, multimedia presentations, etc.)

AMD Green = R: 0 G: 153 B: 102

Orange = R: 255 G: 153 B: 0

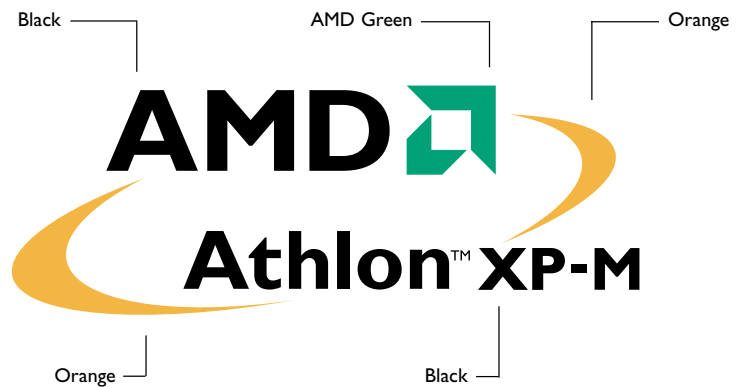

Preserving the Integrity of the Logo Design

The mobile AMD Athlon XP-M processor logo is designed so as to “float” over the selected background. It should be noted that file types other than EPS have inherently predetermined background colors. Authorized mobile AMD Athlon XP-M processor logo artwork in the form of a JPEG, GIF, or TIFF file will have a “built-in” white or black background. Always place these types of logo versions over backgrounds in like color to avoid the appearance of a solid white or black box encompassing the logo itself.

Trademark Usage Guidelines for Mobile AMD Athlon™ XP-M

The following information addresses the correct treatment of the mobile AMD Athlon™ XP-M processor logo and trademarks for use in advertising, technical communications, marketing collateral, and other printed, Web, or visual materials for the mobile AMD Athlon XP-M processor.

- AMD's trademark is "AMD Athlon." The "AMD Athlon" trademark is one term, with a space between "AMD" and "Athlon." If the designator "XP-M" is used, there should be a space between "AMD Athlon" and "XP-M." When referring to AMD Athlon XP-M processors, the use of the term 'Palomino' is strictly prohibited. The codename may only be used when referring to the core technology for comparisons within the same product family name (e.g., Barton and Thoroughbred for AMD Athlon XP-M processors).

- In the title, in the first occurrence in text, and in other prominent instances (i.e., in bold, in header or footer), always follow the "AMD Athlon" mark with a superscripted ™.

Right: "The mobile AMD Athlon™ XP-M processor sets a new performance standard..."

Right: "The mobile AMD Athlon™ XP-M processor 2200+ sets a new performance standard..."

Right: "The mobile AMD Athlon™ XP-M processor with QuantiSpeed™ architecture sets a new performance standard..."

Wrong: "The mobile AMD Athlon processor™ XP-M sets a new performance standard..."

Wrong: "The mobile AMD™ Athlon XP-M processor 2200+ sets a new performance standard..."

Wrong: "The QuantiSpeed™ mobile AMD Athlon™ XP-M processor 2200+ sets a new performance standard..."

- When referencing a model number, always include a descriptive phrase or bulleted text conveying the performance of QuantiSpeed™ architecture, as well as the speed at which QuantiSpeed architecture operates:

Right: "Mobile AMD Athlon™ XP-M processor 2200+"
*QuantiSpeed™ architecture outperforms competitive 2.2GHz processors.
 QuantiSpeed architecture operates at 1.8GHz.

Right: "The mobile AMD Athlon™ XP-M processor 2200+ with QuantiSpeed™ architecture* outperforms competitive 2.2GHz processors."
*QuantiSpeed architecture operates at 1.8GHz

Right: In point of sale materials, printed advertisements, or other media utilizing bulleted lists, etc., *Figure 1* below highlights the correct usage:

Wrong: Any implementation that deviates from the three examples given above.

- Follow the term “mobile AMD Athlon XP-M” with an appropriate generic term such as “processor,” “device,” etc.
- Do not split the “XP-M” designator or the “AMD Athlon” trademark between the end of one line and the beginning of the next.

Right: “AMD designed the mobile AMD Athlon™ XP-M processor...”

Right: “AMD designed the mobile AMD Athlon™ XP-M processor 2200+...”

Wrong: “AMD designed the mobile AMD Athlon™ XP-M processor...”

Wrong: “AMD designed the mobile AMD Athlon™ XP-M processor...”

Wrong: “Mobile AMD Athlon™ XP-M processor...”

Wrong: “Mobile AMD Athlon™ XP-M processor 2200+....”

- In each publication that uses the “AMD Athlon” trademark, provide a trademark attribution notice that includes all AMD trademarks used in that publication, material, or item. For example:

AMD, the AMD Arrow logo, AMD Athlon, and combinations thereof, are trademarks of Advanced Micro Devices, Inc.

- When the performance designator “XP-M” is used in connection with the “AMD Athlon” mark, the following format should be used:

The mobile AMD Athlon™ XP-M processor XXXX+ (where XXXX equals the model number of the processor).

Right: “The mobile AMD Athlon™ XP-M processor delivers next-generation features...”

Right: “The mobile AMD Athlon™ XP-M processor 2200+ delivers next-generation features...”

Right: “The mobile AMD Athlon™ XP-M processor with QuantiSpeed™ architecture delivers next-generation features...”

Right: “The mobile AMD Athlon™ XP-M processor 2200+ with QuantiSpeed™ architecture delivers next-generation features...”

Wrong: “The mobile AMD 1.8GHz Athlon-XP-M processor with QuantiSpeed™ architecture delivers next-generation features...”

Wrong: “The 2200+ mobile AMD Athlon™ XP-M processor delivers next-generation features...”

Wrong: “The mobile AMD Athlon™ XP-M processor-2200+ delivers next-generation features...”

8. When using QuantiSpeed™ architecture or “DDR memory support” as descriptive additions to the mobile AMD Athlon™ XP-M processor name, the following format must be used:
 - Right: “The mobile AMD Athlon™ XP-M processor supporting DDR memory..”
 - Right: “The mobile AMD Athlon™ XP-M processor with QuantiSpeed™ architecture..”
 - Right: “The mobile AMD Athlon™ XP-M processor 2200+ supporting DDR memory..”
 - Right: “The mobile AMD Athlon™ XP-M processor with QuantiSpeed™ architecture and supporting DDR memory..”
 - Wrong: “The mobile AMD Athlon™ DDR XP-M processor..”
 - Wrong: “The mobile AMD Athlon™ XP-M DDR processor with QuantiSpeed™ architecture..”
 - Wrong: “The DDR mobile AMD Athlon™ XP-M processor..”
9. The following trademark attribution must be used when featuring the “Powered by DDR Memory” logo and the “QuantiSpeed” trademark in conjunction with AMD Athlon XP processors:

AMD, the AMD Arrow logo, AMD Athlon, and combinations thereof, and the Powered by DDR Memory logo and QuantiSpeed are trademarks of Advanced Micro Devices, Inc.
10. You may not modify or re-create the “AMD Athlon” trademark under any circumstances. You may not translate the trademark for non-English documents.
