## **OFFICIAL RULES AND TERMS**

## VOID WHERE PROHIBITED. NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sponsor: The AMD AI Developer Program Monthly Member Sweepstakes ("Sweepstakes") is Sponsored by Advanced Micro Devices, Inc., 2485 Augustine Dr., Santa Clara, CA 95054. <a href="https://www.amd.com">https://www.amd.com</a> ("Sponsor" or "AMD").
- 2. Eligibility: The Sweepstakes is open only to persons who are at least 18 years of age and legal residents of the fifty (50) United States of America (including the District of Columbia) or Canada (each an "Eligible Country"), who register as a member of the AMD AI Developer Program (the "Program") by visiting [https://www.amd.com/en/developer/ai-dev-program.html] ("Participant"). Entries received from individuals located in or residing in any country other than an Eligible Country, as noted above, as well as any resident of Belarus, Burma/Myanmar, Cuba, Iran, North Korea, People's Republic of China, Russia, the Sudan, Syria, Venezuela, and/or any country prohibited by law or export restrictions or otherwise, regardless of legal residency, will be disqualified. Residents of the regions of Crimea, Donetsk, and Luhansk are not eligible. Employees of Sponsor, its subsidiaries, affiliates and agents, and the immediate family (defined as parents, children, siblings, domestic partner, husband, or wife) of each such employee, together with those with whom such employees are domiciled, are not eligible to participate. - **4. Sweepstakes Period** The Sweepstakes Period begins on Thursday, January 1, 2026, at 8:00 AM Central Time ("CT"), and ends on Friday, December 25, 2026, at 12:00 AM CT ("Sweepstakes Period").

Sponsor's computer systems will be the official timekeeping device for the Sweepstakes.

**5. How to Enter:** Participants must sign-up for the AMD AI Developer Program. Visit https://account.amd.com/en/forms/registration/ai-dev-program.html to sign up. Participants in the AMD AI Developer Program may be automatically entered into the Sweepstakes when they register

for the Program. **No purchase or payment is necessary to enter or win.** Automatic entry does not increase your chances of winning. The monthly random drawings will be held on the last Friday of each month during the Sweepstakes Period. If you prefer not to be automatically entered, you may opt out by sending an email to <u>Al\_DEV\_PROGRAM@AMD.COM</u>. Entrants who do not opt out of automatic entry will be automatically entered on a monthly basis throughout CY 2026. **For Program members who do not wish to participate, only one (1) opt-out is required to be removed from the monthly automatic entry.** 

For All Entries: Limit one (1) Entry per person, per month. Entrants who submit an opt-out request can retract their opt-out by sending an email to [Al\_DEV\_PROGRAM@AMD.COM] on or before the last Friday of each month during the Sweepstakes Period. Sponsor will auto-enter all members of the AMD AI Developer Club who have not opted out, beginning on or around the last Wednesday of the month until the last Friday of the month. All opt-outs will be honored for the duration of the Sweepstakes. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any Entry, the Authorized Account Holder of the email address used to Enter the Sweepstakes will be deemed to be the Participant. The "Authorized Account Holder" is the natural person assigned the email address used to register for the Sweepstakes, as that is determined by the Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder. Prize Notification and Delivery: Sponsor will notify the potential winners by sending an email to the email address associated with the Participant's AMD AI Developer Program membership, within five (5) business days after the last Friday of each month during the Sweepstakes Period. Such notification will be delivered in English. Within (48) forty-eight hours of the Sponsor's notification, winners must supply any requested information for the administration of the Sweepstakes. The potential winners will be required to sign and return to Sponsor, a fully completed and legible Declaration of Eligibility, Liability and Publicity Release ("Declaration"), except where prohibited by applicable law, to claim their prize.
